Ukuze kunikwe ifuthe kweli lungelo iPalamente iwise umthetho i-Water Services Act 108 of 1997. Injongo yalo Mthetho kukunika ilungelo ionikezo-manzi olungundoqo kune neenkonzo zogutyulo Iwelindle ezingundoqo.

Lo Mthetho uqonda ukuba ilungelo lokufumana unikezo-manzi olungundoqo kune nakwiinkonzo zogutyulo Iwelindle ezingundoqo kuyimfuneko ukuqinisekisa amanziawaneleyokunyenokusingqongileyo okungenakutshabalalisa impilo okanye ukuphila kwabantu nezilwanyana.

- USomqulu wama-Arabhu wamaLungelo oLuntu (2008)

Ngubani onoxanduva lokuhambisa amanzi neenkonzo zogutuulo lwelindle?

Kukho uxanduva kuwo onke amacandelo karhulumente ukuqinisekisa ukuba amanzi neenkonzo zogutuulo lwelindle ziyanikezwa ngendlela eyaneleyo, enobulungisa nezinzileyo.

Onke amacandelo karhulumente kufuneka azame ukunikeza amanzi neenkonzo zogutuulo lwelindle ezanele ukuphila nomsebenzi wezoqoqosho oluzinzileyo.

Indima karhulumente yile:

- Urhulumente wesizwe kufuneka alawule imithombo yamanzi ngeebhodi amanzi ezahlukahlukenyeyo;
- Oomasipala banoxanduva lokuhambisa iinkonzo zamanzi nezogutuulo lwelindle kwaye kufuneka bazobe izicwangciso zokuhambisa. Ezi zicwangciso kufuneka zithathele ingqalelo iinkonzo zokuhambisa ezisebenzayo kubahlali basematyotyombeni;
- Umthetho wethu uqonda ukuba ngenxa yokunqongophala kwemithombo urhulumente akanako ukunikeza ezi nkono kumtu wonke ngoko nangoko. Nangona kunjalo, urhulumente kufuneka abe nesicwangciso esicacileyo esinamaxeha abekiweyo noqingqo-mali ukunikeza ezi nkono kwaye kwandiswe ufikelelo;
- Urhulumente kufuneka enze njalo ngaphandle kokufaka engozini amanye amalungelo angundoqo.

Kwisiphelo seeNjongo zoPhuhliso zeMillennium ngowe-2015, iNdlu yoWiso-mthetho Jikelele yeZizwe eziManyeneyo yasungula i-2030 ye-Ajenda yoPhuhliso oluZinzileyo, eyazisa iiNjongo zoPhuhliso oluZinzileyo (ii-SDG). UMzantsi Afrika uzinike uxanduva lokuphumeza ii-SDG ngamaxeshesha amisiweyo.

INjongo 6 yee-SDG ijongene nelungelo leenkondo zamanzi nezogutuulo lwelindle kuye wonke umntu:

- Ukuqinisekisa ubukho nolawulo oluzinzileyo Iwamanzi nogutuulo lwelindle kumntu wonke;
- Ngowe-2030, iphumeze ufilelelo lukazwelonke nolunobulungisa kumanzi okusela akhuselkileyo nafikelelekayo kumntu wonke;
- Ngowe-2030, iphumeze iinkonzo zogutuulo lwelindle olwaneleyo nolunobulungisa kune nezempi kumntu wonke, kwaye iphelise ukuzithuma embonakalweni, kuthathelwa ingqalelo eyodwa izidingo zoomama namantombazana kune nabo bakwiimeko ezisesichengeni.

ISebe lezaManzi noGutuulo IweLindle lingumgcini wemithombo yamanzi yaseMzantsi Afrika. Linikwe igunya lokukhuthaza ulawulo Iwemithombo yamanzi olusebenzayo nolwaneleyo ukuqinisekisa uphuhliso Iwezoqoqoshno nolwezentlalo oluzinzileyo. UMzantsi Afrika unomgaqo-nkqubo¹ weenkonzo ezingundoqo ezingahlawulelwayo (umgaqo-nkqubo wabangamahlwempu) ukuquka amanzi, umbane kunye noqokelelo lwenkunkuma ukuqinisekisa ukuba:

- Umzi ngamnye kufuneka ufumane iilitha zokuqala zamanzi ezingama-6 000 mahala ngenyanga. Amanzi asetyenziswe ngaphezulu kwala kufuneka ahlawulelwe. Amanzi ahlawuliswa ngokwerhafu yenkonzo enyukayo okuthetha ukuba okukhona uwasebenzisayo, kokukhona abizayo. Kuzwelonke ama-92,5% emizi ayafikelela kwimithombo yamanzi okusela ephuculweyo;²
- Oomasipala abohlukenyero banemigaqo-nkqubo eyahlukenyero yeenkonzo zamanzi nezogutuulo lwelindle mahala. Ungafumana ezi nkonzo ngokuzenzekelayo okanye kuza kufuneka uzibhalisele iinkonzo.

Apho kufunyanwa khona uncedo



- Unelungelo leenkondo ezingahlawulelwayo kwaye unelungelo lokwazi isizathu sokuba ungafulani iinkonzo ezaneleyo;
- Kufuneka uxelele umasipala wakho, uceba wewadi okanye umsebenzi wophuhliso lwasekuhlaleni ukuba uneengxaki;
- IKomishini yamaLungelo oluntu (IKomishini/ i-ne-SAHRC), amanye amaziko akwisahluko 9 somgaqo-siseko kunye namaqumrhu angekho phantsi kukarhulumente(ii-NGO) nawo angakuncedisa ukuba ufumane ulwazi olufunayo.

Amalungelo akuSomqulu wamaLungelo anxulumene

Ilungelo ngalinye kuMgaqo-siseko wethu lilingana nelinye kwaye amalungelo axhomekeke kwelinye nelinye. Umzekelo, ngaphandle kwamanzi kunzima ukufunda esikolweni nokufumana imfundo.

Onke amalungelo oluntu ayathungelana kwaye elinye lixhomekeke kwelinye. Ilungelo leenkondo zamanzi nezogutu yulo lwelindle anxulumene namalungelo obomi, esidima, empilo, okuba nendlu, okuba nokutya, okufunda, iindlela zokuqinisekisa ukhuseleko, ukulingana ngokwesini, kanye nokuthintelwa kocalucalulo. Ukungafikeleli kwiinkonzo zamanzi nezogutu yulo lwelindle kuneempembelelo ezimbi ezinini.

AMALUNGELO AKUSOMQULU WAMALUNGELO ANXULUMENE, UMZEKELO:

- **Ukudluliselwa kwezifo ezinokunqandwa ezinjengorhudo neholera;**
- **Abantwana, ingakumbi amantombazana, banento yokuyeka phakathi esikolweni ukuba azikho iifasilithi zangasese;**
- **Ukusetyenziswa kwezibhedlele neeklinikihi kuyanda;**
- **abantu abayi emsebenzini kwaye ayibonakali into abayenzayo emsebenzini;**
- **Amabhinqa ayoyika ukuya kwizindlu zangasese ebusuku ngokoyikisela ukhuseleko lwabo.**

Ubuncinane bama-26% (3.8 miliyon) bezindlu kwiindawo ezisesikweni aneenkonzo zogutu yulo lwelindle ezingahlangabezaniyo nomgangatho ofunekayo ngenxa yemeko emandundu yamaseko, ebangelwa kukunqongophala kthesakhono sezobuchwepheshe ukuqinisekisa ukusebenza okukuko, ulungiso olukhawulezileyo, ukuhlaziya, kanye/okanye ukuphuculwa kweenkonzo zokukhutshwa kwelindle kwizindlu zangasese zomngxuma, kanye /okanye neenkonzo zemithombo yamanzi ezinqongopheleyo.³

Abemi namaqumrhu angekho phantsi kukarhulumente badlala indima ebalulekileyo ekubekeni iliso ekuqondweni okuqhube kayo kwelunglelo leenkondo zamanzi nogutu yulo lwelindle.

Ukunyhashwa kwelungelo lokufikelela kwiinkonzo zamanzi nezogutuulo Iwelindle kuphezulu kakhulu eMzantsi Afrika, ukunyhashwa okumandla kusenzeka kubahlali basezilalini nabasematyotyombeni. IKomishini ifumana izikhhalazo ezininzi malunga neenkonzo zamanzi nezogutuulo Iwelindle. Phakathi kowe-2012 nowe-2016 iKomishini yamkele izikhhalazo ezingama-1 363 malunga nokunyhashwa kwelungelo lokufikelela kwiinkonzo zamanzi nezogutuulo Iwelindle.⁴

Ukunyhashwa kwamalungelo okufikelela kwiinkonzo zamanzi nezogutuulo Iwelindle, akukhokeleli kuphela kukunyhashwa kwamanye amalungelo angundoqo, kodwa futhi ngamanye amaxesha kubangela izihlandlo zoqhankqalazo ngabahlali abaxhalatyisa kukunqongophala kweenkonzo ezaneleyo.

linkundla zicacisile ukuba abantu banelungelo lokufikelela kwiinkonzo zamanzi. Izigwebo ezibalulekileyo zeenkundla zinika oogunyaziwe abanoxanduva isikhokelo malunga nokubandakanya umsebenzi wabo wokunikeza iinkonzo zamanzi aphucukileyo nogutuulo Iwelindle. linkundla ziqonde ukuba ilungelo leenkonzo zamanzi nezogutuulo Iwelindle labo bonke abemi baseMzantsi Afrika libalulekile elizweni ukuphelisa ukungalingani; indlala, ukuphucula nokukhusela amanye amalungelo anjengelungelo lokufikelela kwiinkonzo zempilo nezemfundo.⁵

Kwizikhala zo ezibini zasekuqaleni kwiKomishini, abahlali baseMakhaza, eKhayelitssha naseRammulotsi eFreyistata bakhala zangasese kwiinginqi zabo.

Uphando IweKomishini Iwaveza ukuba abantu bezi ngingqi maninzi amalungelo abo angundoqo anyhashiwego. Babenyanzelwa ukuba bahlale kwiimeko ezingekho mpilweni nezingakhuselekanga nanjengoko kwakufuneka basebenzise izindlu zangasese ezingavalwayo, ezazingacocekanga kwaye zichasene nemithethosiseko neendlela ezilandelwayo zokuphunyezwa kweenkonzo. IKomishini yayalela ukuba oomasipala bathabathe amanyathelo akhawulezileyo okukhusela ubucala, isidima, ilungelo lokusingqongileyo okucocekileyo nokukhuselekileyo namalungelo okufikelela kwiinkonzo zamanzi nezogutuulo lwelindle zabahlali.

IKhomishini futhi yayalela iSebe loBongameli loCwangciso, lokuBeka iliso nokuHlola (i-DPME) ukuba linike ingxelo iKomishini ngelungelo leenkonzozogutuulo lwelindle kwilizwe liphela. I-DPME yanika ingxelo yokuba kwakukho iingxaki eziqhubekeyo nezinabileyo ngokuphathelele “kusilelo lweenkonzo zamanzi ezingundoqo nemingeni ngokunjalo ezanxulunyanisa nokusilela kwenkxaso-mali eyaneleyo kunye nokuqokelelwa kwengeniso okusilelayo okukhokelela kukungazinzi kweemali; ukusilela kwezakhono zobuchwepheshe, zolawulo nezoshishino; ungenelelo Iwezopolitiko norhwaphilizo kunye namandla angacacanga akwamasipala kwanemisebenzi.”⁶

IKomishini yathetha ngokusesikweni ngeziphumo nezindululo zayo nepalamente kazwelonke emva kokuba ukumanyelwa kwamatyala kuqhutywe kuwo onke amaphondo malunga nokunyhashwa kwamalungelo okufikelela kwiinkonzo zamanzi nezokugutuulo lwelindle. Iqhubekeyo nokuqokelelwa iliso kwaye inike ingxelo ngelungelo kwaye iphendule izikhala zo ezigiswa ngabahlali. Kutshanje iKomishini iye enkundleni malunga nokuthotywa kwamaxhala egameni labahlali kwiPhondo loMntla Ntshona.⁷ Kule meko, amanzi ayenikezelwa nguMasipala kodwa ayengazanelanga izidingo zabo.⁸
